Implement Good Mining Practice, ANTAM Received 17 GMP Awards 2024

Jakarta, September 30, 2024 - PT Aneka Tambang Tbk (ANTM), or ANTAM, received an award for its achievements in implementing Good Mining Practice ("GMP") from the Ministry of Energy and Mineral Resources ("GMP Award 2024").
