With respect to the letter from Indonesia Stock Exchange No. S-00428/BEI.PP1/01-2021 dated January 18, 2021 regarding Request for Clarification on the News Circulating in Mass Media, herewith PT Aneka Tambang ("ANTAM"), give our clarification such as follows:

- In conjunction with the judgment of Surabaya District Court in the case of a lawsuit of Budi Said ("Plaintiff") concerning the purchase of gold in a boutique in Surabaya on January 13, 2021, ANTAM, by its attorneys, will take a legal proceeding for an appeal the case. The Company is adamant that it is not guilty with respect to the lawsuit filed by the Plaintiff.

- ANTAM advises the customers to always be careful against suspicious offers or sale scheme of ANTAM's precious metals made by any persons.


