ANTAM Shares Remain Parts of Leading Index Share on the IDX

Jakarta, February 15, 2024 - PT Aneka Tambang Tbk (ANTAM; IDX: ANTM; ASX: ATM), a member of PT Mineral Industri Indonesia (Persero) (MIND ID) - the State-Owned Enterprise Holding of Mining Industry, announced that the Company remains part of the LQ45 Index, IDX30 Index and IDX80 Index in Indonesia Stock Exchange (IDX) based on the evaluation result conducted by IDX, with an effective period from February 1, 2024 until July 31, 2024. The LQ45 Index, IDX30 Index and IDX80 Index comprise of Listed Companies in IDX with the highest liquidity and higher market capitalization and also supported by good Company fundamentals.

ANTAM Director of Finance and Risk Management, Elisabeth RT Siahaan said:

“The re-establishment of ANTAM shares in the LQ45 Index, IDX30 Index and IDX80 Index on the IDX reflects the positive appreciation from shareholders of the Company’s shares performance. In addition, the Index can be used as an investment reference for shareholders. ANTAM always continues to carry out product innovation and sustainable business development to provide added value to shareholders.”

ANTAM shares are actively traded on the Indonesia Stock Exchange every day, at the end of January 2024 the closing price of ANTAM’s shares recorded Rp1,550 per share. The solid performance of ANTAM’s shares was also reflected in the average daily trading volume of ANTAM’s shares on January 2024 reached 42.14 million shares, with the average daily transaction value on January 2024 recorded Rp68.70 billion. At the end of January 2024, ANTAM market capitalization amounted Rp37.25 trillion. The shareholders trust is also reflected from the number of shareholders who invest their shares in ANTAM. On January 2024, ANTAM’s total shareholders reached 222,049 investors, or increased 18% compared to the total shareholders in January 2023 of 188,808 investors.

In addition, ANTAM's shares are also listed in several indexes on the IDX, such as Kompas100 Index, MNC36 Index, IDXBUMN20 Index, Investor33 Index, Jakarta Islamic Index, Jakarta Islamic Index 70 Index, Indonesia Sharia Stock Index, IDX MES-BUMN 17 Index, SRI-KEHATI Index, ESG Sector Leaders IDX KEHATI Index, ESG Quality 45 IDX KEHATI Index, LQ45 Low Carbon Leaders Index, IDX High Dividend 20 Index, IDX Small-Mid Cap (SMC) Composite Index and IDX SMC Liquid Index which are the group of stocks with the highest liquidity in IDX. Meanwhile, ANTAM's stock remained part of MSCI Global Standard Index of Indonesia. MSCI is an index published by Morgan Stanley Capital International.
