The A Series Share owned by the Government of the Republic of Indonesia will not be transferred and therefore, the Government of the Republic of Indonesia will remain to own special rights that are not provided to the holders of the B Series Shares in the Company, as stipulated under the provisions of the Articles of Association of the Company.
